A skilled litigator, Saba routinely represents companies and high-net-worth individuals in complex commercial litigation covering a variety of areas, including securities, business torts, partnership disputes and real estate litigation. She has represented companies in industries ranging from energy and manufacturers to landlords and investors.

Saba is experienced in a variety of arbitration venues, including the Financial Industry Regulatory Authority (FINRA), and she has represented consumers and financial advisors in financial disputes. She also works with clients in the live events and hospitality industries, providing industry-specific legal counsel.

Representative Experience

- Successfully defended a solar energy construction contractor against \$17 million arbitration claim filed by the plaintiff, an engineering, procurement and construction (EPC) contractor. Following the conclusion of an eight-day arbitration hearing, Saba secured an arbitration award that denied numerous damages claims, including plaintiff's \$11.4 million claim for liquidated damages as an unenforceable penalty. Despite being sued as the defendant, Saba's client paid zero dollars to the plaintiff, and ultimately recovered over \$3.16 million on its own counterclaims.
- Secured a settlement of \$2.61 million on behalf of a solar energy renewable labor supplier for a 2,000-acre solar farm installation project in multi-party lawsuit. Saba's team secured a decisive win excluding an expert witness and defeating the general contractor's motion for summary judgment and summary motion for lien removal. All four adverse parties settled within one week of the win.

- Obtained a \$3.5 million settlement in FINRA arbitration on behalf of a client investor who was defrauded in a Ponzi scheme.
- Secured the dismissal of a \$27 million premises liability dispute on behalf of Dallas-area nightclub investors, including a retired professional athlete.
- Secured a take-nothing verdict in favor of a Texas-based manufacturer of award-winning downhole sand and gas separation products in a patent infringement lawsuit involving downhole tube separators.
- Secured a judgment exceeding \$24 million on behalf of an elderly individual investor against a financial advisor in a Ponzi-scheme dispute.
- Defeated a \$4.7 million lost-profits claim on summary judgment against an electric delivery provider in a negligence and gross negligence dispute.
- Secured a take-nothing summary judgment against a \$3 million age-discrimination claim filed by a high-level sales director against a manufacturer for prefabricated construction solutions; the judgment was later affirmed by the U.S. Court of Appeals for the Fifth Circuit.
- Obtained a summary judgment in favor of a commercial landlord real estate investment trust and successfully defended the summary judgment on appeal.
- Served as lead counsel for dozens of garnishments across Texas and successfully defended garnishments at oral argument in motions to dissolve writ of garnishment hearings, with one garnishment resulting in the full satisfaction of a judgment exceeding \$500,000.
